NOMINATION FORM FOR TRUSTEE 2022

CRITERIA FOR AMSUK ELECTION OF TRUSTEES

1. All AMSUK members can nominate another member of the community provided that:
 - a. The nominee agrees to be nominated, and will complete and sign the Nomination form.
 - b. The nominee and the nominator both have to be paid-up members of AMSUK.
 - c. In the event no nominations are received or do not meet the criteria set in (2) below, then the Election Committee can accept a nomination for the Trustees post from the members present at the AGM on the day.

2. A nominator should consider the following criteria when nominating an individual for the position of a Trustee:
 - a. The Trustees must come with an excellent character background.

 - b. They must be senior members of the organisation.

 - c. They must have held high office or have served for a long period of time.

 - d. They must be politically neutral.

3. All Nomination forms should be sent to the AMSUK Secretary in a sealed envelope clearly marked "AMSUK Trustee Nomination Form" together with the sender's Name/Address on reverse of the envelope if an acknowledgement is required.

4. The AMSUK Secretary should receive all the nominations 5 days prior to the date of AGM. Late nominations could be considered but only if received **before** commencement of the AGM on the day of the Elections. Those Nominations received after commencement of the AGM will be considered void.

5. All nominations received by the AMSUK Secretary will remain in the sealed envelopes and be handed over to the AMSUK Holding Trustees on the day of the Elections. The sealed envelopes will be opened by the Holding Trustees before the commencement of the AGM.
